- 2. The truing up for FY 2014-15 is proposed as per the actuals of FY 2014-15 in accordance with GERC (Multi Year Tariff) Regulations, 2011. The Revenue Gap/(Surplus) of FY 2016-17 for Surat Supply Area is arrived at considering the provisional ARR for FY 2016-17 and estimated revenue at existing tariff on Approved sales as per the Hon'ble Commission's order dated 2nd December, 2015 in Petition No. 1534/2015.
- 3. The cumulative gap for tariff determination of FY 2016-17 works out to Rs. 178.73 Crores. TPL has not proposed any change in existing tariff rates. TPL has proposed to recover this gap through Regulatory Charge with a cap on the recovery of FPPPA plus Regulatory Charge at Rs. 1.93 per unit with effect from 1st April, 2016. This proposal will ensure a minimum reduction of at least 5 paise per unit to the consumers from their current level of billing
- TPL has proposed to determine the wheeling charges and crosssubsidy surcharge applicable to Open Access consumers.
- 5. Base FPPPA is Rs. 1.23 per unit.
