PUBLIC NOTICE

1. Torrent Power Limited (hereinafter referred to as “TPL”) has filed its petition vide Case No.1554/2015 for Truing up of FY 2014-15 and determination of tariff for FY 2016-17 for its distribution business of Dahej Supply Area.
2. The truing up for FY 2014-15 is proposed as per the actuals of FY 2014-15 in accordance with GERC (Multi Year Tariff) Regulations, 2011. The Revenue Gap/ (Surplus) of FY 2016-17 for Dahej Supply Area is arrived at considering the provisional ARR for FY 2016-17 and estimated revenue at existing tariff on Approved sales as per the Hon'ble Commission's order dated 2nd December, 2015 in Petition No. 1534/2015.
3. The cumulative Surplus for tariff determination of FY 2016-17 works out to Rs. 1.60 Crores. In turn, TPL has proposed to adjust this cumulative Surplus through revision in tariff. TPL has proposed to implement the revised tariff with effect from 1st April, 2016.
4. The proposed tariff schedule for FY 2016-17 for Dahej Supply Area is given below

Notes:-

- i) The Billing Demand will be taken as under:
 - The Maximum Demand recorded during the month or
 - 85% of the Contract demand or
 - HTP – 100 KVA & LTMD – 15 KWWhichever is highest.
 - ii) **Applicable to HTP-I, HTP-II, HTP-III and HTP-IV:**
 - **Power Factor Adjustment Charge**
 - a) The power factor adjustment charges shall be levied at the rate of 1% on the total amount of electricity bills for the month under the head “Energy Charges” for every 1% drop or part thereof in the average power factor during the month below 90% up to 85 %.
 - b) In addition to the above clause, for every 1% drop or part thereof in average power factor during the month below 85% at the rate of 2% on the total amount of electricity bill for that month under the head “Energy Charges”, will be charged.
 - **Power Factor Adjustment Rebate**

If the power factor of the consumer's installation in any month is above 95%, the consumer will be entitled to a rebate at the rate of 0.5% in excess of 95% power factor on the total amount of electricity bill for that month under the head “Energy Charges”, for every 1% rise or part thereof in the average power factor during the month above 95%.
 - iii) **Night Time Concession charges - Applicable to HTP-I**

For the consumer eligible for using supply at any time during 24 hours, entire consumption shall be billed at the energy charges specified above. However, the energy consumed during night hours of 10.00 PM to 06.00 AM next morning as is in excess of one third of the total energy consumed during the month, shall be eligible for concession at the rate of 75 Paise per unit.
 - iv) ToU charges applicable to HTP-I, HTP-II and HTP-III for consumption during specified hours
 - Applicable for consumption during the peak periods, viz. 0700 Hrs to 1100 Hrs and 1800 Hrs to 2200 Hrs.
 5. TPL has proposed to determine the wheeling charges and cross-subsidy surcharge applicable to Open Access consumers.
 6. Base FPPPA is proposed to be revised to Rs. 0.28 per unit.
